What Are Core Services?

Remember that your CIL or ILC (Independent Living Center) must provide all the core services to qualify as a Center for Independent Living.

The Core Services are

- Information and referral;
- IL skills training;
- Peer counseling;
- Individual and systems advocacy; and
- Services that facilitate transition from nursing homes and other institutions to the community, provide assistance to those at risk of entering institutions, and facilitate transition of youth to postsecondary life.

What is Independent Living Skills Training?

People with disabilities must have the same opportunities as everyone else to:

- Choose for themselves where to live
- Earn a living
- Lead the lives they want
- Make decisions about their lives

But sometimes there are things they need to learn to be independent, and that is where you come in.

The individual identifies what they need to learn to meet their independent living goals.

Independent Living Skills Training provides that support by teaching the needed skill.

And don't we all have things we still want to learn?

How and where are these skills taught?

It depends. What makes the most sense?

- Is this something a group can learn together? Then you might use a classroom.
- Is this something specific to a new living setting like using the stove or other appliance? Then it needs to be taught at home.
- Does a curriculum make sense? There are some out there are some of these skills like financial literacy or emergency preparedness.
- Does sharing your own experience make sense? Then you teach with an element of peer support.

Are you the only teacher of these skills?

For example, can the bank teach someone how to open a bank account without you? Maybe just help the consumer compile questions to ask?

Are there community volunteers that can assist with compiling a book of favorite easy menus or assisting with genealogy?

Are there public meetings to learn about emergency planning?

If they want to get involved with a church, can the church assign a mentor or friend to assist?

Remember increasing community involvement is also one of our tasks.
